Fees / Billing:

The Town of Biggar will invoice in January for the full calendar year (12 months) in advance. Payment is due 30 days from invoice date. The annual fees for each sign in the urban sign corridor are:

- (a) \$100.00 per 4' x 8' sign plus applicable taxes;
- (b) \$300.00 per 10' x 20' sign plus applicable taxes;
- (c) \$450.00 per 10' x 44' sign plus applicable taxes;
- (d) \$450.00 plus applicable taxes for any size sign used as a rental billboard;

Terms & Conditions:

1. There are a limited number of sign spots in each sign corridor location.
2. The dimensions of the signs or sign stands cannot be altered and signs that include design elements that extend out beyond the specified 4' x 8', 10' x 20' or 10' x 44' dimensions will not be permitted.
3. Sign-spots are awarded subject to availability on a first come first serve basis.
4. The Town of Biggar reserves the right of refusal as to what businesses are allowed to have signs in the sign corridor. Political, religious or offensive content will not be permitted.
5. Each business is only permitted to have one sign in each of the four sign corridors.
6. Upon approval of this application, it is the responsibility of the applicant to produce their own signs.
7. Signs must be the correct dimensions and professionally produced.
8. Signs must be metal or backed with a minimum of 3/8" plywood.
9. The Town of Biggar is the only authorized agent for installing the finished signs.
10. Finished signs must be ready for installation within two months of the date of the approval of this application. The Town of Biggar would be contacted regarding installation. Failure to do so will result in the forfeiture of the sign-spot. Forfeited spots will be awarded to the next applicant.
11. A standardized Town of Biggar black metal silhouette sign-frame may be installed above/below all signs in any of the sign corridors.
12. Any damages to any sign caused by weather, wildlife, motor vehicles or other equipment are the responsibility of the sign owner to repair. The Town of Biggar does not accept any liability for any damages to the signs erected in the Town of Biggar sign corridor. Arrangements must be made with the Town of Biggar to retrieve damaged signs so that repairs/replacement can be undertaken. Repairs and/or replacement must be undertaken at the sign owner's expense.
13. The Town of Biggar reserves the right to direct that damaged and/or weathered signs be repaired or replaced at the sign owner's expense. Failure to repair / replace damaged or weathered signs within the specified timeframe will result in a forfeiture of the sign-spot.
14. Failure to pay the annual invoice before the specified deadline will result in a forfeiture of the sign-spot.

I also acknowledge that I have read and understand the terms & conditions outlined in this document. I understand that I am not able to proceed until I have received written notification from the Town of Biggar that this application has been approved and a sign-spot has been designated.
